


# The Provider Conference was well organized


# The conference sessions allowed for meaningful engagement




### I learned new information at the Provider Conference



The event location (Portland State University) was accessible and met my needs 62 responses




The event accommodations (rooms, refreshments) we accessible, and met my needs 62 responses

This will help reduce our shelter stays so more unsheltered can utilize the shelters. Therefore while we are talking about increasing shelters, we must figure out how to help those in shelter access the services they need otherwise more shelters will not help the overall issue.

- in general as i have stated before my main wish would be to have more handouts/take home material for the team members who were unable to attend the conference or who were in other sessions.
- More opportunities for collaboration between attendees. There also was not really a vegan option for food, would be better to have a clear option next time.
- More workshops!
- I would have appreciated more break out groups and opportunities to network. It's so rare to get so many of us together, I wish we could have had a little more intentional time to exchange ideas and information.
- Offering testimony on budgets came up a few times informally, and I'd love to see more
  coordination among providers (maybe through JOHS) on being both aware of public
  timelines for budgetary processes, the opportunities to provide testimony (written or
  verbal/in-person) and how we might better plug into these processes to fund our
  programs and more directly lead the city and county's public policy from our frontline
  learnings.
- I would have liked to have just the tiniest bit more structure to lunch/networking. I
  attended alone and did not know anybody else at the conference, and it would have
  been nice to have had some prompts or shuffled around seating or something to
  encourage conversation.
- I would love to see a space dedicated to booths with with different resources and representatives from those organizations to network with.
- The vegan meals provided were not vegan
- The rooms were over-filled, not enough seating and table space to feel comfortable. Not
  enough seating options for heavy and fat people. Not enough signage directing us to
  rooms. I got a parking ticket for parking in the wrong lot. I would not choose this location
  again due to confusing parking, small rooms and inadequate seating.

- Offer the other trainings' during different times. So if people are intersected they can attend. For example I had to pick in between sessions and could not attend all.
- Please have water available not just coffee.
- I would have liked to have had more workshops to choose from during the afternoon session. I felt the morning session was loaded with relevant topics, but neither afternoon session really fit my needs, whereas the morning sessions had several workshops of interest to me and felt more relevant to my work. Overall, I thought it was great and appreciate all the work and thought put into the conference and look forward to the next one!
- I think I could've used more required net-working time. There were teams/groups I wanted to meet but didn't have the capacity to look at every name tag to find/meet them.
- I think the planning could have been a lot more thoughtful on every level.
- Ice breaker events to meet other folks attending. Questions to audience members to spark conversation amongst attendees.
- Process was not over all super engaging, networking opportunities were limited.
- More topics with open round table presentations. Have people network by sitting in other tables to know who the other service providers are in the area.

- As for the lunch boxes, I saw a lot of food waste happen. Perhaps there could have been a box for the unwanted items (half sandwiches not eaten, apples, cookies), as we do serve the houseless and have many agencies in the room that can take it back to their centers/shelters.
- It would have been great to have more time for networking.
- lunch distribution was unnecessarily slow. Even with the concern of not having enough lunches, one simply had to count how many people were left in line and how many box lunches were left on the table.
- Have more presenters of color (Black, Native person, Asian and Hispanic) addressing the subjects directly relevant to communities of color.
- I would love to see more practitioner led sessions to share skills and learning across organizations and experiences.
- Either having more structure for the closing/feedback structure or offer another afternoon session. So much great info, I heard multiple people struggling to choose which to attend, which is definintely an indicator that the topics were important and needed info for our community!
- I really wish there was more time for meeting folks from other organizations!!!
- I definitely encourage being really thoughtful about food. I know y'all tried to be. But when I went to get a vegan lunch, the people said the vegetarian options are both vegan. Except they weren't. And since I have a food allergy, if I hadn't been paying attention, I would have gotten really sick. Something I've been encouraging folks to think about doing is having meals that are all vegan and gluten free so that everyone's needs are met and there are options for people!
