Land & Labor Acknowledgement

Multnomah County rests on the stolen lands of the Multnomah, Kathlamet, and Clackamas Bands of Chinook Indian Nation; Tualatin Kalapuya; Molalla; and many others along the Columbia River. Updated Draft Definitions for the Committee's Top Priorities



Framing the Conversation: Draft Definitions

What are we talking about?

Each year the committee identifies its top two SHS priorities and prepares recommendations. In the last few months the committee has done initial work to define these priorities. The SHS team has prepared updated drafts of both definitions for the meeting today.

Why is it important?

Having a clear definition of each priority will provide a framework that the committee can use when developing recommendations. It is the jumping off point to the rest of the process.

Collaboration: Problem Statement

Problem statement: why do we need better collaboration?

In Multnomah County there are many entities working to address homelessness, but they often operate in isolation from one another and have different goals and priorities. When collaboration does happen, historical exclusion of Communities of Color has led to disparities in who has a seat at the table and whose voices are heard, resulting in inequitable solutions that don't work for everyone. All of this makes it harder for our system to be effective and for people to access the right services when they need them most. When we don't collaborate, we risk disconnected and duplicated work, and the perpetuation of existing power structures and silos that maintain inequities and make it harder for people to get housed.

Collaboration: Definition

What does collaboration mean to this committee?

While bringing together many perspectives can be complex, building these relationships is essential for shared growth and success. Collaboration is about bringing everyone to the table to work toward shared goals and a more connected system that better serves people experiencing homelessness. Working together expands our impact and leads to better decisions by combining the resources and knowledge each group has to offer.


The committee would like to see enhanced collaboration and engagement within the Homeless Services Department and between the Homeless Services Department and external partners. Collaborative spaces should provide a platform for Communities of Color, Black communities, and those with lived experience to speak truth to power. For this to happen, collaborative partners must commit to building relationships rooted in trust, respect, and accountability by showing up with curiosity and humility and thoughtfully examining implicit biases and power dynamics.

Framing refresher: access

In the May meeting members suggested using the term "accommodations" to refer to accessibility specifically related to physical access and the unique considerations for differently abled folks.

For clarity, the SHS team also modified the overall priority name from "accessibility" to "access," as access more accurately captures how the committee is defining this priority.

Access: Problem Statement

Problem statement: why do we need better access?

When someone is at risk of or becomes homeless in Multnomah County, getting help is not easy. It's not clear to people where to go, and it's hard to get a complete picture of what resources are available. There are many access points and pathways, and the process is often confusing even for people who work in the system.

When a person does enter the system, they face further barriers to access in the form of historic & current discrimination and disparities, and ineffectively designed program and system-level policies. On top of all of this is the fact that there simply aren't enough housing resources, which is both causing homelessness and making it worse, and not enough supportive services to go around.

Access: Definition

What does access mean to this committee?

Because of this, the SHS Advisory Committee would like the Homeless Services Department to lead efforts to improve access to homeless and housing services in Multnomah County.


Access in supportive housing means that all individuals — regardless of race, ability, gender, orientation, background, or mental, physical, or behavioral health status — can meaningfully and easily access, navigate, and benefit from housing and the services that support housing stability. Access is about physical space, but it's also about designing systems that are inclusive, equitable, and responsive to real-life barriers to housing.


