Review of HSD Budget rebalancing efforts	HSD Business & Operations Manager Senior provided updates about the changes to County/HSD budget (see CBAC meeting presentation slides) as presented to the County Board of Commissioners earlier today  Q&A  Q: Any info whether local government do any	
	affordable housing reform? A: City has some avail units and County &City will work together to move folks into more affordable units, but haven't heard about any policy  O: How was it decided to fully fund 2 of 3 areas with backfill? A: when state legislature expect will fully fund	

to maintain shelter, had funds for long-term rent assistance, but did not have enough for rehousing Q: Will there be an opportunity in a short session to advocate for additional State funding for next FY? A: Yes, but there is \$3M deficit for state; County commissioners strategizing • Q: Does long term rent assistance include specific programs? A: will respond later in writing Q: Would the families or participants that might not get the housing dollars be transferred to other housing services or programs or what happens to them? A: one HSD priority is to make sure currently housed folks stay housed, so keep services for those currently being served; detail of what this will look like is coming October 16th the County Board of Commissioners will finalize the rebalanced budget. Presentation -HSD Planning & Evaluation Manager walked the Committee **HSD Data** through HSD's Data Dashboard Q&A Q: In the Who Is Experiencing Homelessness in Multnomah County graph, does "sheltered" include people in shelter and long-term housing? Where do folks in cars or couchsurfing exist? A: "Unsheltered" includes anybody we don't see in a shelter. "Sheltered" does not include people in housing; only those in shelters that enter data and those in temporary transitional housing are included. Q: Any way to see DV data? A: Not publicly available; kept in a fully protected site. Will look for available reports to share. Q: Does this data include City funded shelter programs? A: Yes, any shelter that enters data into HMIS in included, but new shelters don't come online until 1-3 months from program launch

	<ul> <li>Q: At last Provider Conference, I saw a dashboard with organizational outputs A: That was the contract monitoring dashboard</li> <li>Q: In the shelter section, if you select the Family system, there's a huge drop in people enrolled lag in data or actual drop? A: will get back to you about that; not a big system, so small change can look like a large drop</li> <li>Q: Is the data showing families or individuals in families? A: Individuals</li> <li>Demand far exceeds supply, especially looking at Population A; HRAP is starting to model out the impact of each service on the entire system. Will share when available.</li> <li>Consider when looking at dashboard, if we have aggregated, we probably have de-aggregated data as well.</li> <li>Q: How fast could the Committee get data that is not available in the dashboard as we move into the budget process? A: It depends; we have a data mart that makes data gathering a lot faster than in the past</li> </ul>
