Group Agreements	Reviewed past group agreements (see meeting slides) & discussed what agreements help make for a strong, inclusive and participatory committee • CBAC members spoke to how each agreement is resonates with them (please refer to the slides) • 1. Remember we're human and take care of our bodily needs; doesn't mean conversations will always be comfortable • 2. Creates a safe and brave space where we can talk about difficult topics and still be heard • 3. Some people are more verbal, some more visual, etc. Appreciate Zoom allows people to use the chat. • 4. Gives each person opp to voice ideas and step back for others • 5. Self-awareness, personal reflection; thinking about our identities and lived experience when we're together in a space; prework can be looking at the agenda and consider your positionality in regard to items • 6. Researched evidence vs personal opinion • 7. Have lived experience and used the system, why important to be on the CBAC; hope everyone is bringing their own experience • 8. Safety means participating does not cause harm; may still not feel great or comfortable, but not being harmed • 9. Each person can call out oppression, not just those harmed CBAC used the fist-to-five consensus tool to approve current group agreements.

What's next with the CBAC?	Reviewed expectations for the next several months (see meeting slides) Q: What happened this past FY and when, with the State budget affecting the County budget requiring a rebalance? A: County had to finalize its budget before the State did. Revenue from the State differed (was much less) after legislature input than what the Governor originally proposed. Q: Does the federal shutdown affect Multnomah County, and is there anything in place to still get providers what they need? A: There may be some contingency funds to help cover costs when HUD payments are held up. Q: Is the general fund forecast still scheduled for Nov. 6 (great opportunity for learning about funding)? A: Bill will confirm and email about it. Appreciate the early opportunity to recommend priorities. Providers were engaged for input about the budget at the Provider Conference. Reviewed CBAC topics of interest list created at August CBAC meeting (see meeting slides); highlighted items: HSD pilot programs, including coordinated outreach SHS LIP and HRS HRAP as guiding documents and how they factor into County's priorities Ballpark of budget constraints for next year's budget	CBAC Chair offered to provide a survey to get further feedback about the list.
