Kose mwochen kopwe cheki ren noumw ewe supervisor me email hmishelp@multco.us ika pwe ee or omw kapas eis.

Mi required an upwe angei ei ROI seni ewe participant?

Uu. Nupwen ka fori ewe minafon program enrollment non HMIS, meinis in ekkewe providers ir mi required ar repwe makketiw ika pwe ewe client mi wau an mwumwuta an epwe tou porous me non ewe HMIS ar nounou ewe ROI aa kawor meren HSD. Ewe ROI ese chok awora ewe taropwen legal ren an ewe client tipew, an sipwe kuna ekkoch porous me non HMIS an epwe mwut ngeni ekkewe providers ar repwe tongeni anisi ekkewe clients, ren an epwe nukunukeoch ewe sasingin services ngeni clients ren ar ra angei ewe continuum, me aninis ren taropwen chronic homelessness.

Inet atun upwe aneani ewe Verbal ROI ngeni participants?

Kopwe aneani ewe script ngeni ewe participant atun ewe program intake. Kopwe makketiw ar kana “uu” ika “apw” ren penuweni ren ewe Verbal ROI form. Kopwe akomwa ei mwen omw kopwene rekotunatiw porous kan a non HMIS. Agency staff repwe pwisin nenengeni inet atun repwe aneanau ewe Verbal ROI atun ewe intake.

Mi required ewe signature seni ewe participant won ewe ROI?

Apw, ewe signature ese pwan required. Meininisin ekkewe participant repwe era ika ir mi tipew ngeni an epwe tou ar kewe data non HMIS ika espw tou. Ika pwe ewe participant mi or noun semirit (kukun seni ewe 18 ier), iwe repwe pwan era ika ir mi tipew ngeni an epwe pwan tou an nour kewe semirit data non HMIS ika esapw. Ekkewe chon angang repwe makketiw ekkewe penuwan won ei form.

Emon watte mi tongeni epwe pwan tipew ngeni an epwe tou an emon pwan ekkewe watte data me non chok ar ewe household?

Apw, emon me emon watte (18 ier ika eta) me non ena household iwe repwe pwisin awora ar mwumwuta. Ew Verbal ROI epwe kawesino ren emon me emon watte me non ewe household

Pwan met sokkun porous mi tongeni epwe tou nge ese pwan fiti ewe release?

HMIS data mi tongeni epwe katou nukun ewe HMIS ngeni chok ekkoch aramas non organizations ir mi angei ar mwumwuta ren chok ekkoch pekin wewe. Epwe chok iei ewe case ika pwe HMIS Privacy & Security Notice mi mwutata Ena pekin wewe nge epwe chok ika pwe ena porous epwe tou nge esapw fiti ewe release mi afateti non

ewe Privacy & Security Notice. Ena link ngeni ena Privacy & Security Notice iwe ina ee nom fan ena kapas eis, “lan upwe tongeni kuna me ian tichikin unusen an ewe participant pwung ngeni porouser kewe?” fan na
Ikkei pwan ekkoch awewe nupwen porousen emon epwene tou nge ese fiti ewe release:

- Ika pwe ewe agency aa transfer ini ewe program ngeni ew minafon agency iwe ewe minafon agency aa mwochen an ewe aramas ekkewe contact information ren ewe participant.
- Ren omw kopwe confirm ika ewe participant mi eligible ren ew program
- Ika pwe ewe participant mi or an medical emergency (e.g. heart attack ika watte fiengawan), mi peno iwe ekkewe first responders ra eis iten ewe participant me inet upwutiwan ren ar repwe tongeni kuta an ewe medical rekot
- Ika noun ewe participant souennuk aa mwochen porouser kewe
- Ika pwe ewe County auditor aa mwochen ren an epwe access ngeni ekkewe porous non HMIS ren an epwe tongeni audit ika ewe good government hotline ren ototur
- Ika pwe ee or ewe court order ika ew valid subpoena

Katon ena Privacy & Security Notice ren unusen tichikin porousen an ewe participant pwung.

Ion mi tongeni kuna an ewe participant data ika pwe mi katou non HMIS?

Katon ena HMIS Privacy & Security Notice ren tichikin porous ren ion mi tongeni aces ngeni HMIS data. Ena link ngeni ena Privacy & Security Notice iwe ina ee nom fan ena kapas eis, “lan upwe tongeni kuna me ian tichikin unusen an ewe participant pwung ngeni porouser kewe?” fan na.

Ifa ukukun taman an epwe nomw en data an aa katou?

Chinon ekkewe chok basic porous ach sipwe tongeni sinei ion me ion, data sharing iwe ina epwe ukukun 7 ier seni ewe ROI pwopwutan pwinin maram. Ren ach sipwe fori pwungun angang, kose mwochen kopwe fori ekkei tetenin foror:

1. Kopwe fori ewe ROI pwopwutan pwinin maram epwe nene ngeni ewe pwopwutan pwinin maramen program.
2. Esisina ena ROI Kosopwonon Pwinin maram epwe nene ngeni ewe ROI pwopwutan pwinin maram *kapach fisu ier*.

Met upwe fori ika pwe ewe participant aa tipew ngeni ewe ROI terms ew ika fen mwirin fitu ranin ar ra fen tonong non ewe program?

Kopwe fori ena ROI pwopwutan Pwinin Maram epwe chok pwan nene ngeni ewe pwopwutan pwinin maramen ewe program ina mwo ika re tipew ngeni ewe ROI nge aa mwirin fitu ran. Pwokiten pwisin angangen ei system an aa foruta, ina pwata mi euehea ena kinikinin an epwe tongeni kinamwe sasan ekkei data. Sa chok nuku nge ewe participant mi weweiti met ewe ra tipew ngeni ren ewe data sharing *ren ewe program ra enroll non*.

Epwe fitu ROIs upwe tongeni wanong non HMIS?

Makkenong ruu ROIs non ena HMIS: ew ren omw ewe login provider me ew ren ewe program ena participant aa mwochen fiti. Ika pwe kose tongeni kopwe kuna ekkena providers ren an epwe tongeni fis ei metoch, iwe kose mwochen kopwe mak ngeni hmishelp@multco.us ren aninis.

Ika pwe emon era “apw” ngeni ewe ROI, ngang upwe chok pwan makkenong non en HMIS?

Uu, chon angang repwe chok makkenong ekkena ROI’s ren participants rese angei mwuwmutan repwe share data. Ren ekkewe aramas rese tipew ngeni an epwe tou ar kewe data, iwe “Permission Granted” field epwe nene ngeni “apw” non ena ROI non HMIS. Ika pwe “Permission Granted” aa nene ngeni “apw”, data esapw chiwen tongeni katou. Ekkei ROIs nge repwe chok makkenong ren pisekin pwarata nge ewe participant mi nomw iwe kich mi ngeni an epwe finata.

Nge ewe Verbal ROI Form sipwe chok pwana nomwu?

Uu, ena kapin mi kawes iwe epwe nomw non an ena participant file non ukukun 7 ier.

Ewe Verbal ROI form mi need epwe pwan uploaded non HMIS?

Apw, ewe digital kapin ei form ese pwan need epwe uploaded ngeni HMIS. Ewe physical form iwe kopwe anomwu non ukukun 7 ier.
