Main Points from Session Overview/Presentation:

 Immigration is natural, people have always looked for to different parts of the world to look out for ourselves and family

Preparedness

- Do you know your Constitutional Rights?
- Protocol if federal agents show up at your home/work?
- o Identified private v. public space
- Who are your direct and rapid responders?
- Done practice drills on scenarios in case federal agents show up
- WHat resources in the community
- Know where the rapid response teams in area
- Know OFA, ECO, PIRC, and FPP guide?
- All people in the US regardless of immigration status we have rights
- As community members we should be prepared to keep each other safe and minimize trauma

Know your rights

- We all have the right to remain silent
 - Important to exercise the right to remain silent verbally. If we answer questions we open up the opportunity for agents to further investigate us.
- We all have the right not sign anything without speaking to a lawyer, especially if we don't understand what it says
- We all have the right to refuse permission to search or enter

- It is important to not open the door unless we know who is on the other side
 - Officers might try to use their foot to leave the door open and start intimidation tactics
 - Signed warrant by Judge or magistrate would allow them to enter with or without your permission
 - What agents might provide is an Order of Removal signed, but it is not the same and does not allow them to enter
 - 3 elements of a valid warrant include (Administered by a court, addressed to the right person, and signed by a judge)
- Oregon Sanctuary law gives use the right to not have our state government workers collaborate with ICE without a warrant
 - Does not mean agents will stop making arrests
 - It is against Oregon law for state and local governments like police or sheriff, department human services etc to collab or participate with immigration enforcement without a court order
 - This law has kept Oregon's low detentions compared to other states
 - In states where it is high it is because State is working with agents
- o If agents show up at your building
 - Have a protocol or Call PIRC 1-888-622-1510
